Parish Councillor A Darbyshire proposed & Parish Councillor S Rudge seconded Vice-Chairman N Wood to Chair the meeting.

Vice-Chairman N Wood took the Chair and opened the meeting.

**Public Question Time:** A member of the public asked if the Parish Council could consider applying to Barmoor Wind Farm for funding to purchase at least 1 hand grit spreader and or 1 towing grit spreader. Parish Councillors agreed to make investigations.

A member of the public raised concerns about the abandoned vehicle in Branxton village. County Councillor M Mather advised the meeting he still looking into finding a resolution to get the vehicle removed.

A member of the raised concerns about vegetation overhanging the footpath in Branxton village. Parish Councillors agreed the Clerk send a letter to each property asking them to organise the cutting back of the vegetation, and if this is not successful then ask County Councillor M Mather to raise the issue with Northumberland County Council.

**Min 609- County Councillor report-** County Councillor M Mather gave the following verbal updates:

The Local Area Councils are wishing to re-engage with members of the public and Parish Councils.

This area has not submitted many applications to Northumberland County Council Community Chest, so please consider submitting applications.

There is a £50,000 Northumberland County Council King's Coronation fund, there is a maximum of £500 per application. I will provide a letter of support if required as part of the application.

There had been a meeting in Wooler recently to look at increasing tourism for the whole area, it is hoped that Northumberland County Council will run the project, the staff cover will be ½ a day per week.

Parish Councillors raised concerns that the potholes were filled on the road past Branxton Buildings using the old method, which meant there was grit on the road within days. County Councillor M Mather stated he still hoped that the potholes in North Northumberland will eventually be filled using the new method of cut out and replace, however, in the meantime he encouraged everybody to report potholes on the Northumberland County Council website.
